

PRIVACY POLICY

This document is an electronic record in terms of Information Technology Act, 2000 and rules there under as applicable and the amended provisions pertaining to electronic records in various statutes as amended by the Information Technology Act, 2000. This electronic record is generated by a computer system and does not require any physical or digital signatures.

This document is published in accordance with the provisions of Rule 3 (1) of the Information Technology (Intermediaries guidelines) Rules, 2011 that require publishing the rules and regulations, privacy policy and Terms of Use for download, access or usage of our Website. T-Fund Foundation ("T-Fund", "**Company**", "**we**", "**us**", or "**our**") owns and controls the website, www.t-fund.co ("**Website**") which facilitates in incubation services ("**Services**") to startups ("**you**", "**your**", "**user**").

T-Fund and its affiliates respect your privacy. This Privacy Policy describes in brief the manner in which your data is collected and used by us. WHO COLLECTS THE INFORMATION?
